# Minutes of the Kitchener PAC Meeting \& AGM 12:45pm - Thursday, May 9, 2013

1. Call to Order: The meeting began at $12: 45$ pm. The minutes of the April 2013 meeting were reviewed and accepted. Moved by Melody and seconded by Victoria. Passed.
2. Principal's Report - Dennis Taylor:
a. Sports Day is next Friday, May $17^{\text {th }}$ from 9am-12:30pm.
b. Alpha Secondary PAC meeting is June 3 - all parents of Grade 7 Kitchener students are welcome to attend.
c. The school will be painted over the summer.
d. Kindergarten enrollment is currently 40.

## 3. Treasurers' Report - Binita:

April 2013 fundraising activities:
Proceeds from the LaMontagne chocolate fundraiser totaled $\$ 4,594$. PAC will retain $50 \%$ of this (Will be approximately $\$ 2200.00$ ). Payment has not been made to LaMontagne yet.

Yearbook sales totalled $\$ 1,390$ at a price of $\$ 10 /$ ea, with all proceeds going to LifeTouch.
Consistent with prior years, there was no mark up in price to keep costs affordable for families. Payment has not been made to LifeTouch yet.

During the month we also received a $\$ 330$ rebate from LifeTouch (percentage of sales).

## 7. New Business:

c. PAC Constitution proposed by-law changes - Victoria: each individual proposed change was reviewed and voted on (see attached proposed changes):

- Secretary: Melody nominated Kristina Murray; accepted. Seconded by Tommasina. All in favour - passed.
- Treasurer: Victoria nominates Janice and Binita, seconded by Kristina. All in favour - passed.
- DPAC Representative: Kristina nominated Victoria Brenden; accepted. Seconded by Melody. All in favour - passed. Second position to be filled in September.
- Fundraising Committee Chair: carried forward to September. Position open
- On-line administrators: Claude will continue, but looking for someone new in September.
- SPC: Tommasina nominated Melody Eng, Nikki Levis and Victoria Brenden; all accepted. Seconded by Binita. All in favour - passed.
- Members at Large: Doreen and Sherri.
